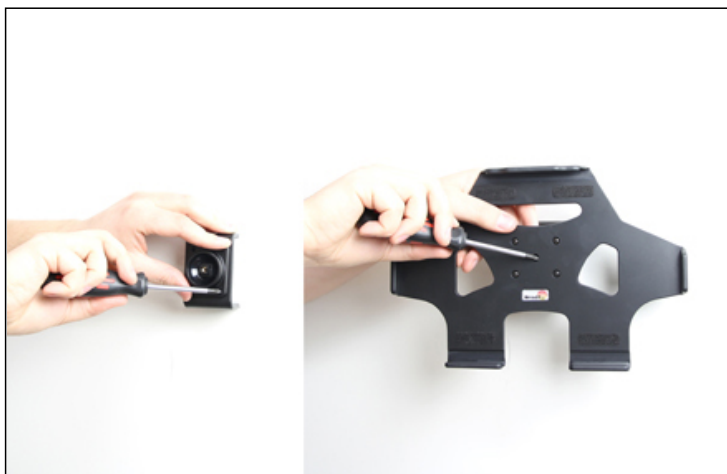

1. Unscrew the screw in the center of the holder and remove the holder from the Tilt Swivel base plate.



2. Place the base plate over the matching holes in your mounting bracket (demo ProClip mount shown in picture) Attach the base plate by using the self-tapping screws. Note: The machine screws with nuts are for mounts made of metal with large holes. Start to thread the center screw into the base plate. When you connect with the nut pull the holder towards you to prevent the nut from spinning around. Continue to tighten the screw firmly. Then loosen the screw slightly for easier angling/rotation of the holder.



3. To place the device in the holder: Place the lower part of the device in the holder, then flip/press the upper part forwards so it snaps into place in the holder. To remove the device from the holder: Press upwards on the upper part of the holder, in the same time pull the upper part of the device out from the holder and then lift the device up and out from the holder.



4. The holder is in place.
